- HD Cartwright is a Gr. 7-9 junior high school with 480 students
- Many students have cell phones and access to technology at home.
- Students access and use a variety of technology in the school including iPads, computers, & Chromebooks

Relevant evidence and data that informs your Digital Citizenship Plan:

- CBE Students Survey statement: "I take care of myself by making sure that I don't have too much screen time" Overall agreement = 45% (Spring 2024)
- CBE Student Survey Question: "If a relationship is no longer positive, I know what strategies I can use to address it." Overall disagreement = 26% (Spring 2024)
- CBE Student Survey Question: "I treat people with the same respect online as I would face-to-face." Overall disagreement = 19% (Spring 2024)
- Anecdotal data:

- o high percentage of office referrals dealing with student conflict that originated online
- o high number of requests from parents for support with digital citizenship issues
- o high number of students who indicate that their interactions online are often negative

During the 2024-25 school year, students at HD Cartwright will have the opportunity to utilize tablets, computers, online applications, and other digital resources. Each student and parent/guardian is expected to read this document and all students are expected to adhere to the Admirable Use Policy as described below. Please contact your child's teacher or your school administrator if you have questions or concerns.

Digital Technology for Learning

The use of technology is an integral part of learning at all CBE schools, as required by Alberta Education's Information and Communication Technology (ICT) Program of Studies. Students are encouraged to use our network and digital learning tools to collaborate with others and contribute to the learning environment in meaningful, positive ways. By utilizing the school's digital resources and/or network, students agree to the guidelines for digital technology use outlined in this document. They also agree to the Digital Citizenship guidelines about technology use in the school. Students will engage with digital technology to:

- Access, critically assess, and communicate information and understanding
- Seek alternative viewpoints
- Collaborate during inquiry
- Construct personal knowledge and meaning
- Demonstrate understandings
- Organize and manipulate data
- Interact and share learning with others

Acceptable use includes:

- Only accessing CBE or personal technology when given permission
- Treating CBE and personally owned technology with care and respect
- Using personal devices at appropriate times for learning and knowing when to put it away
- Use of a student's own account only to access the CBE network
- Never assuming the identity of another person
- Accessing, posting, sending or downloading appropriate material only
- Using respectful language and being honest and kind in digital communications
- Respecting other students' work on any device. Refraining from copying, changing or removing another student's work from a device, school network, or the internet

- Giving credit to authors or sources when using information or ideas that are not the student's own (including the use of Artificial Intelligence) - failure to properly cite sources of information is called plagiarism and is a form of cheating
- Asking permission to post, publish, circulate, record, or distribute someone's personal information (images, work, etc.)

CBE My Devices Network

The CBE My Devices Network enables students to access wireless Internet on school-owned technology or students' personal devices. Students are expected to follow this Admirable Use Policy when assessing this network. The school does not accept any responsibility for loss or damage of any student's personal electronic devices.
